

# **WORK SAFETY RULES - GUIDE FOR ASSEMBLY TEAMS**

Safety during assembly is a shared responsibility, and each exhibitor must ensure that all activities related to their booth are planned and executed with attention to safety, the health of the teams involved, and care for the environment.

In addition, it is the exhibitor's duty to:

- Interrupt any activity that poses an immediate risk to people's safety or health.
- Require the correct use of PPE (Personal Protective Equipment) by all contracted service providers.
- Request and verify valid certificates of the Regulatory Standards (NRs) required from the companies involved in the booth assembly.

# **MANDATORY CERTIFICATIONS**

The following certificates are required for participation in the exhibition assembly:

TYPE	PURPOSE	WHO MUST HAVE IT
NR10	ELECTRICAL	1 responsible person per exhibitor
NR35	WORK AT HEIGHT	1 responsible person per exhibitor
NR18	SAFETY AND HEALTH	ALL
OCCUPATIONAL SAFETY TECHNICIAN / ENGINEER	MEZZANINE	1 technician/engineer per exhibitor + 1 NR10 responsible per exhibitor + 1 NR35 responsible per exhibitor
INFORMATIONAL VIDEO	Exhibitors + Agencies	Exhibitors, agencies, and service providers who will access the event during the assembly period for supervision purposes
INTEGRATION VIDEO*	For those without NR certificates	Assemblers and service providers of any kind who will work onsite and do not present an NR18 certificate

# **Exhibitors + Agencies**

Exhibitors, agencies, and service providers who will access the event during the assembly period for supervision purposes must watch an informational safety video.

#### Who does not have NRs

Assemblers and service providers of any kind who will work on-site and do not present an NR18 certificate must watch an integration video.

# All professionals participating in the assembly must, by the decoration day, access the link below and upload their respective certificates:

Professionals who fail to submit their certificates within the deadline must **attend a mandatory on-site temporary training session** before beginning their activities.

#### ASSEMBLY TEAM INTEGRATION

The integration sessions for assemblers will take place during the assembly days, with groups starting every 40 minutes.

This temporary training will cost **R\$80.00**, payable on-site before the session begins. Accepted payment methods: **PIX**, **credit/debit card**, **or cash**.

Members of ABRACE and SINPROM will receive a 50% discount on the integration fee.

After completing the training, participants will receive a **badge** granting them access to the event during the assembly period.

**Important:** This training does **not replace** the official NR certificates and will **not be valid for other events.** 

# **WORK SAFETY RULES - GUIDE FOR EXHIBITORS**

Exhibitors, agencies, and service providers who will **only supervise the assembly (without performing technical work)** must **watch a mandatory safety informational video** of approximately 9 minutes in length.

It is the exhibitor's responsibility to ensure that all involved parties watch the video and **sign the EXHIBITOR LIABILITY AGREEMENT – Work Safety Informational Video** (available in the "ATTACHMENT" section of the exhibitor portal) and submit it along with the project analysis documents.
